On previous date i.e. 23/03/2022 the personal hearing was given to the Chairman of the Trust running the above mentioned colleges as well as Chartered Accountant who audited the accounts of the Institutes and issued audit report which are relied in support of proposals seeking approval of fees.



On the previous date the hearing was adjourned at the request of the Chairman of the Trust & the Auditor to produce the documents like Form Nos. A-1 & A-2, Form Nos. 16, 16A, 24Q, 26Q, bills vouchers and other record supporting the salary and non-salary expenditure, claimed in the proposals as well the payments made through bank transfer as well as cash.

Mr. Kadam the Chartered Accountant appeared and candidly stated that most of the expenditure shown in the proposals including Salary Expenditure has been made in cash. He has produced the Form Nos. A-1 & A-2 in respect of each of the Institute & mentioned therein the salary paid to staff through bank transfer and cash. He submits that he has issued the Certificates in Form Nos. A-1 & A-2 after due verification of the record made available by the Institute and the Trust running the above-mentioned colleges. The Form Nos. A-1 & A-2 produced on record by the Chartered Accountant are taken on record.

Mr. Kadam the Chartered Accountant also placed on record the statement showing the non-salary expenditure made Cash and or by way of Bank Transfer and provided details of the expenditure supported with Bills and without bills.

The Chairman of the Trust requested the Authority to finalized the fees proposals of their Institutes for the academic year 2021-2022 on the basis of record available & produced during the course of hearing. He assured the Authority that in future their Institutes adhere to norms and procedure prescribed and the payments to be made towards salary and non-salary expenditure shall be made through Cheques or Bank Transfer in accordance with the provisions of Income Tax Act & Rules made there under.

It was decided to decided the proposals in the light of the Form Nos. A-1 and A-2 and statement of expenditure produced by the Chartered Accountant as well as the other documents produced during the course of hearing the fees of the courses run by the Institutions mentioned below has been finalized as under; -
